Animal Control

RESPONSIBILITIES OF ANIMAL OWNERS WITHIN THE R.M. OF MOUNTAIN AS PER BY-LAW NO. 02/06

PART IV: PROVISION OF NEEDS

5(1) Every person who keeps an animal within the Urban Districts shall provide the animal...

- (a) clean, fresh drinking water, available and suitable food...
- (b) food and water receptacles kept clean and disinfected...
- (c) the opportunity for periodic exercise...
- (d) necessary veterinary medical care...

PART VI: DOGS, CATS, AND OTHER DOMESTIC PETS

Licensing of Dogs

- 7(1) The owner of every dog over four months shall obtain and renew annually, a license to keep the dog....
- 7(4) payable on the 1st of January in each year and shall expire on the 31st day of December...

Responsibility of Owners Regarding Dogs

- 9(1) No owner shall:
- (a) permit his dog to run at large...
 - (b) permit his dog to bark or howl or in any other way unduly disturb the quiet of any person...
 - (e) permit his dog to damage public property or private property...
 - (g) own, keep, harbor, or have possession or control of any dog determined to be a dangerous animal...
 - (h) permit his dog to pursue, bite, wound or worry any person or animal...
 - (i) permit his dog on any school ground or playground...
 - (j) permit his dog on public property ... unless the dog is on a leash...

RESTRICTIONS ON DOMESTIC PETS

11(2) No person shall, under any circumstance, keep, permit or suffer to be kept within the boundaries of the Urban Districts that type or breed of dog known as the American Pit Bull Terrier, or any dog which has in its pedigree the traits of the American Pit Bull Terrier.

MAXIMUM NUMBER OF DOGS

12(1)(a) No person shall own, harbor, keep or have ... more than two (2) dogs over the age of four months ... unless such person holds a valid kennel permit authorizing him to own that number of dogs.
